Problems and Challenges Faced by Married Students to Continue their Study at University Level

The purpose of the study was to find out the challenges for married women to continue education at university level. Present study was descriptive in nature. The study is significant in terms of exploring the root causes of different problems faced by womanish wedded scholars while antedating advanced education after marriage. Quantitative research methodology was used to collect data. All public and private sector universities in Province Punjab were the population of the study. Researcher used purposive sampling technique to select the sample from population. 75 students were the sample of this study. Self-designed questionnaire was used to collect the data from sample. The data were analyses by using descriptive and inferential statistical techniques. The analysis revealed that the married students faced very critical challenges at higher education in Pakistan. Among these challenges Academic Challenges, Social Challenges, Time Management challenges, Financial Challenges and Health Challenges were found to be common in the married students at higher education in Pakistan. The study has important practical implications in the field of higher education in Pakistan with the recommendations of some modifications and changes in the mechanism of higher education in Pakistan to facilitate the education of married women at higher education.

Illiterately rate of womanish in Pakistan is further than 50 percent, and at advanced position education, the participation of women has adding trend, but their proportion is veritably small. With this background, this study was design to explore social, family problems of wedded women at advanced education. The study is significant in terms of exploring the root causes of different problems faced by womanish wedded scholars while antedating advanced education after marriage. Population of the study was married female students enrolled in public and private Universities of Province (Punjab) and City (Faisalabad). Total number of Universities in Punjab and total number of Universities in Faisalabad these are the public and private sector universities with the variation in the fee structure and number of students. Purposive sampling technique was used to select samples for the present study. Researchers selected 18 Departments of Government College Women University Faisalabad as a sample. 75 female married students from Government College Women University Faisalabad enrolled in graduate level and Postgraduate level was the sample of the study. The minimum age of the participants was 20 years and maximum age was 30 years. The study conducted at Govt. College Women University Faisalabad involved a sample of 75 married students. Descriptive and inferential statistics were used to analyze the data. In descriptive statistics researcher used Mean, frequency, standard deviation and percentage. Correlation was used to identify the statistically significant difference between the variables. For the analysis of the demographic variables ANOVA was used by the researcher.

revealed that the marriage effects academic performance of married women at higher education, the lack concentration during lectures, shows irregular attendance to the classes, cannot continue studies after marriage, cannot maintain balance between family responsibility study, hardly receive support from their in law- in pursuing their higher education goals, feel stress due to university and house responsibility, cannot manage Extra time for personal activities, their house responsibility effect university timing, cannot complete course work and assignment on time, their Spouse cannot manage their finances, they have to take out alone or used credit to finances expenses, Have sleep disorder while pursuing while higher education, have Mental health challenges while pursuing higher education such as anxiety and stress, Experience any pregnancy related complications, have not enough time to exercise or out healthy needs and may experience any nutritional deficiency while studies

Recommendations

In reviewing the findings of the questionnaire, there are certain implications specific to our university and a few for other higher education institutions.

- One of the recommendations is to offer courses with a more blended teaching approach rather than the traditional mode of face-to-face in-class teaching.
- Distance instruction, hybrid courses or accessible courses are other possibilities that could be presented to wedded students.
- At the university level there is a need for educators and administrators to cultivate cultural awareness about family role commitments married female students encounter during their course of study.
- A greater asset in creating program flexibility, actual systems of statement in maintenance and facilities such as adolescent care and therapists could contribute towards positive completion of the degree.
- Hiring capable counselors who comprehend the culture is vital for the establishment of appropriate counseling facilities for all students and precisely when dealing with matters related to wedded students.
